This is a great alternative to pitching. This saves the NHPA and the individual charters potential hardship for those whom may spread or contract COVID-19. Even though you are not showing symptoms, you may be a reservoir for the virus. You could be spreading it and not know it.

All RDs for each charter should have this information. If they do not they should call me at once to get the information.

According to the NHPA RGS book revised January 01, 2019, Requirement 5- Sections A and B allows the NHPA Executive Council to approve or deny special tournament requests. During this time across the world, members of the NHPA have been limited to NHPA sanctioned tournament play due to the corona virus. The NHPA members are unable to compete socially and therefore causing a disruption in pitching schedules across the United States. With our ever-decreasing membership including the decreased match play, this time is crucial to gain membership and aide in the process of keeping horseshoe pitching on the market for posterity. Furthermore, with the current wording of the RGS book and the reasons stated above, the NHPA Executive Council is allowing at home, mail-in, online, horseshoe pitching tournaments to be sanctioned. The "grandfathering" policy approved in 2019, allowed for horseshoe courts to receive "sanctioned" status if unable to meet current specs. With that being said, tournaments may be hosted temporarily anywhere. Members should get in contact with the RDs of

your respective charter to allow for these temporary sanctions of courts. The NHPA Executive Council asks that members keep the integrity of their ringer percentage each game. Tournament directors may execute each event as he/she sees fit. However, all other NHPA Rules and Bylaws must be followed. Games or matches completed that are not used for the specific tournament listed during this time will not be counted for tournament credit. All games completed are a one-time match and must be recorded for the tournament listed in. They cannot serve as double purpose for events. Please keep all games on hand as they are to be sent electronically, or snail mail to each director as having proof of score for the game(s) for that tournament. Leagues may be completed and scored by the means stated above during this time. We hope everyone stays safe during this time and we hope to see everyone on the courts together for tournament competition.

Each of us have been watching the impact of the Coronavirus (COVID-19) on our communities and families. Lives continue to be disrupted with imposed limitations that have affected our activities, including the opportunity to pitch in scheduled NHPA horseshoe tournaments. Many of those tournaments have been canceled to meet community safety guidelines and regulations. The NHPA remains committed to provide a

safe environment for our members while also providing competitive opportunities to pitch horseshoes.

The NHPA council recognizes that with many tournaments being canceled, some members may be limited to meet the minimum required tournaments to qualify for the World Tournament. To provide the best opportunity for individuals to qualify for the World Tournament scheduled July 13-25, the NHPA council has extended the registration deadline until June 1st and reduced the number of tournaments required to qualify from 4 tournaments to 2.

The NHPA Council President, Stuart Sipma, is in regular communication with officials from the City of Monroe, Louisiana and will continue to monitor the situation and the impact of the Coronavirus (COVID-19). The World Tournament is planned to continue as scheduled at the present time. Additional information and adjustments will be made as additional information becomes available.

Your safety is our primary concern! We are looking forward to putting this behind us and seeing each of you bring your best pitching to Monroe Louisiana for the 2020 World Horseshoe Tournament.
